# 1. ENTERING THE CONTEST; START AND END DATES OF THE CONTEST

There is no limitation as to the number of Power Points (as defined below) You may collect. We are not responsible for Power Points that we did not approve for any reason, or for Power Points that are late or incomplete for whatever reason. We reserve the right to approve or reject the collection of Power Points in accordance with these Rules, at our sole discretion.

Participation constitutes your full and unconditional agreement to and acceptance of these Rules. Stage 1 of the Contest will begin on [March 21, 2022] at [08:00 am EDT] and end on [June 20, 2022] at [5:00 pm EDT] ("Stage 1 Period").

We reserve the right to cancel, change or suspend the Contest at our sole discretion, without prior notice.

#### 2. ELIGIBILITY FOR ENTERING THE CONTEST

You are eligible to enter this Contest if You meet the following requirements at the time of entry:

- B. You are not an employee of ControlUp.

- Initiate a POC 200 Power Points
  - Initiate and execute a POC agreement with us.
  - If You are an employee of any entity that initiated a POC with us, You are entitled to receive the Power Points on the entity behalf, provided that You were registered for the Contest prior to the initiation of such POC.

#### Stage 2 – Interviews by Our Panel

The three (3) contestants that will gain the highest number of Power Points will be interviewed and judged using the criteria specified on section 4.

#### 4. SELECTION OF WINNER

After the end of Stage 2 of the Contest, one winning contestant will be selected by the judge(s), out of the three (3) contestants that have collected the highest number of eligible Power Points, based on an interview which, in the sole opinion of the judges, will best express the following criteria:

  - ✓ Send us 1–2-minute selfie video of remote experience while wearing a ControlUp provided shirt (the "Selfie Video").
  - ✓ Participate in a post-Prize interview.

## 5. THE PRIZE

The winning contestant will win a four (4) night, five (5) day trip, up to a \$6,000 cash value.
